FULL PAGE AD: 7.5"w x 10"h OR FULL BLEED: 8.75"w x 11.25"h

HALF PAGE AD: 3.75"w x 10"h OR 7.5"w x 5"h Please Specify Vertical or Horizontal QUARTER PAGE AD: 3.75"w x 5"h

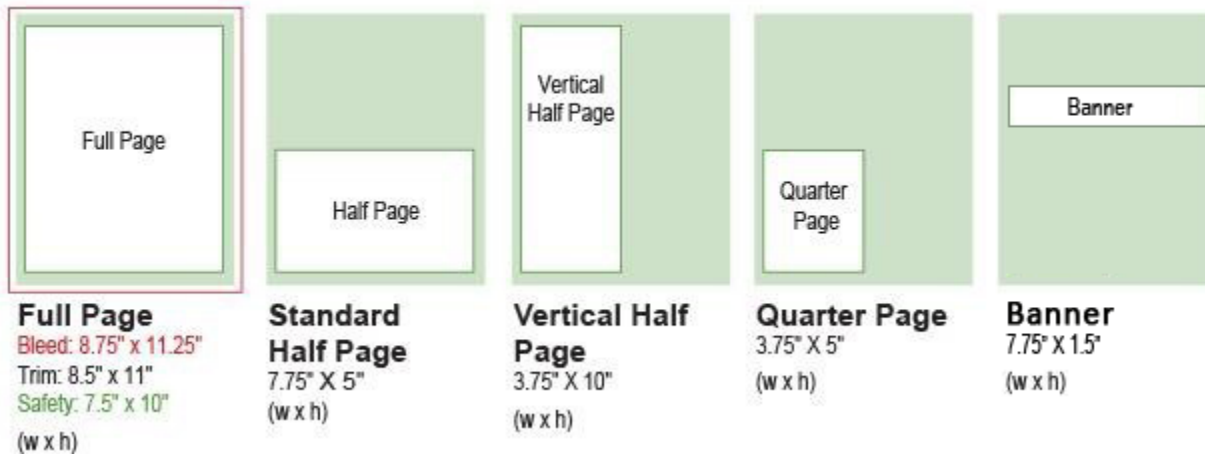
BANNER AD: 7.5"w x 1.5"h (artwork placed on page at the discretion of the editor)
